

Chip Dip Contest Rules & Regulations

September 1st to 30th, 2010

Contest Sponsor:

- The Contest Sponsor is Gateway Casinos & Entertainment Inc. which owns and operates the Baccarat Casino and the Palace Casino located in Edmonton, Alberta.
- These Contest Rules & Regulations are specific to the Chip Dip Contest and prizing available at Baccarat Casino and Palace Casino.

Contest Dates:

- Contest begins at 9:00 am on September 1st, 2010 and closes at 6:55 pm Mountain Standard Time on September 30th, 2010.

Entrant Eligibility:

- The Contest is open to residents of Canada (excluding the province of Quebec) who have reached the age of majority in their Province of residence, except employees, retirees and representatives of the Contest Sponsor (Gateway Casinos & Entertainment Inc.) or AGLC and their respective affiliates, subsidiaries, related companies, agents, associates, dealers, representatives, advertising and promotional agencies and members of the immediate family of those employees and retirees or any persons with whom they are domiciled.
- For the purpose of this Contest, "immediate family" is defined as parent, sibling, spouse, mother, father, brother, sister, son and/or daughter.
- The Contest is also not open to those persons who appear on the Alberta voluntary self-excluded and/or barred persons list.
- In order to be eligible to enter and win any of the Weekly Prize Draws, to be held Thursdays at 7:00 pm, 8:00 pm and 9:00 pm on September 2nd, 9th, 16th, 23rd and 30th, 2010, the entrant must possess and produce a valid Player Rewards member card and have a Player Rewards account in good standing.
- The Player Rewards Program is free to join and application forms and cards are available through Guest Services at either Baccarat Casino or Palace Casino located in Edmonton, Alberta, Canada.
- The Contest Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification.
- All personal and other information requested by and supplied to the Contest Sponsor for the purpose of this Contest must be truthful, complete, accurate and in no way misleading.
- The Contest Sponsor reserves the right, at their sole discretion to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

How to Enter:

Onsite:

- No purchase is necessary.
- Contest entrants who meet the conditions as outlined in the section above are eligible through the following methods:
- Ballots are earned in the following ways at either Baccarat Casino or Palace Casino beginning Friday, August 27th, 2010:
 1. One (1) ballot per day can be earned by swiping your Player Rewards Card through the Player Rewards kiosk at Guest Services each day between 9:00 am and close.
 2. One (1) ballot for each Slot Point Card redeemed at Guest Services, up to a maximum of three (3) per day.
 3. One (1) ballot per day may be obtained by redeeming one hundred (100) Player Rewards Program points through the Player Rewards kiosk located at Guest Services.
- Ballots will be available until 6:55 pm on Draw nights; Thursdays, September 2nd, 9th, 16th, 23rd and 30th, 2010. Ballots will again be available following the draws at 9:05 pm with the exception of the last draw night of September 30th, 2010 where ballots are permanently closed at 6:55 pm.
- Ballots will not be accepted for entry between 6:55 pm and 9:05 pm on draw nights.
 - A maximum of five (5) entries can be earned and entered each day during the Contest.

- The Player Rewards kiosk will automatically print out one entry per card holder during each of the above noted hours when a valid Player Rewards Card is swiped through the kiosk located at Guest Services.
- The entry form that prints from the kiosk automatically contains: the date and time, the eligible entrant's Player Rewards Account Identification number, customer name and reference to where full terms and conditions can be found.
- All entries received have an equal chance of winning. The odds of being randomly selected to win one of the prizes, depends on the total number of eligible entries received.

Prizes & Prize Draws:

The following prizes as described below will be awarded at both Baccarat Casino and Palace Casino during the Contest:

- Three (3) winners names will be drawn (at each property) on each of the draw dates listed above at 7:00 pm and 8:00 pm. Two (2) winners name will be drawn (at each property) on each of the draw dates listed above at 9:00 pm for a total of eight (8) winners per property, per draw date.
- All chips used for the Weekly Draws are stress-ball style "fun chips" approximately 3" in diameter.
- Chips available at the 7:00 pm and 8:00 pm draws:
 - Forty (40) Red chips valued at twenty five dollars (\$25.00) each.
 - Forty (40) Blue chips valued at fifty dollars (\$50.00) each.
 - Forty (40) Green chips valued at one hundred (\$100.00) each.
- Chips available at the 9:00 pm draws:
 - Forty (40) Red chips valued at twenty five dollars (\$25.00) each.
 - Forty (40) Blue chips valued at fifty dollars (\$50.00) each.
 - Forty (40) Green chips valued at one hundred dollars (\$100.00) each.
 - One (1) Black chip valued at one thousand dollars (\$1000.00), two thousand dollars (\$2000.00), three thousand dollars (\$3000.00), four thousand dollars (\$4000.00) or five thousand dollars (\$5000.00) each depending on the previous week's 9:00 pm draw outcomes as outlined below.
- The three (3) winners names drawn at 7:00 pm (Winner #1, Winner #2 and Winner #3) will each pull one (1) chip from the chips available (\$25.00, \$50.00 and \$100.00 value) in the draw drum and can win up to one hundred dollars (\$100.00) each based on which chip value they pull.
- The three (3) winners names drawn at 8:00 pm (Winner #4, Winner #5 and Winner #6) will each pull one (1) chip from the chips available (\$25.00, \$50.00 and \$100.00 value) in the draw drum and can win up to one hundred dollars (\$100.00) each based on which chip value they pull.
- The first winner's name drawn at 9:00 pm (Winner #7) will pull one (1) chip from the chips available (\$25.00, \$50.00, \$100.00 and \$1000.00) in the draw drum and can win up to one thousand dollars (\$1000.00) based on which chip value they pull. If the first winner at 9:00 pm (Winner #7) pulls the \$1000.00 value Black chip, it does not go back into the draw drum.
- The second winner's name drawn at 9:00 pm (Winner #8) will pull one (1) chip from the chips available:
 - If Winner #7 **did not** pull the \$1000.00 value black chip, Winner #8 will pull from the \$25.00, \$50.00, \$100.00 and \$1000.00 value chips and can win up to one thousand dollars (\$1000.00) based on which chip value they pull.
 - If Winner #7 **did** successfully pull the \$1000.00 value black chip, Winner #8 will pull from the \$25.00, \$50.00 and \$100.00 value chips and can win up to one hundred dollars (\$100.00) based on which chip value they pull.
- In the event that neither of Winner #7 or Winner #8 pulls the \$1000.00 value Black chip; that \$1000.00 value of the Black chip will be added to the 9:00 pm draw the following week. This will continue each week:
 - Week Two (September 9th, 2010), 9:00 pm draw only:
 - No \$1000.00 winner from Week One (September 2nd, 2010) there will be one (1) Black chip available worth \$2000.00.
 - A \$1000.00 winner from Week One (September 2nd, 2010) there will be one (1) Black chip available worth \$1000.00.
 - Week Three (September 16th, 2010), 9:00 pm draw only:
 - No \$2000.00 winner from Week Two (September 9th, 2010) there will be one (1) Black chip available worth \$3000.00.
 - A \$2000.00 winner from Week Two (September 9th, 2010) there will be one (1) Black chip available worth \$1000.00.

- Week Four (September 23rd, 2010), 9:00 pm draw only:
 - No \$3000.00 winner from Week Three (September 16th, 2010) there will be one (1) Black chip available worth \$4000.00.
 - A \$3000.00 winner from Week Three (September 16th, 2010) there will be one (1) Black chip available worth \$1000.00
 - Week Five (September 30th, 2010), 9:00 pm draw only:
 - No \$4000.00 winner from Week Four (September 23rd, 2010) there will be one (1) Black chip available worth \$5000.00.
 - A \$4000.00 winner from Week Four (September 23rd, 2010) there will be one (1) Black chip available worth \$1000.00.
 - If at any time during a 9:00 pm draw a Black chip is drawn, regardless of it's value, the following week's 9:00 pm draw will revert back to the original one (1) Black chip valued at one thousand dollars (\$1000.00) and the increasing prize scale will be followed from that week when necessary.
 - There will be only one (1) Black chip prize available to be won each week regardless of it's prize value.
 - If a Black chip is drawn by the first winner at 9:00 pm (Winner #7 each week), there will not be a Black chip prize available to the second winner at 9:00 pm (Winner #8 each week).
- The Prize Draw Winners will be randomly selected from all eligible entries received before the time of ballot cut off as outlined above for each of the draws listed above.
 - The Prize Draw Winners must be in attendance at the time of the prize draw and will have three (3) minutes from the time their name is announced to approach the draw area to identify themselves to the Contest Sponsor in order to claim their prize.
 - In the event that a Prize Draw Winner whose name is randomly drawn does not approach the draw area and identify themselves within three (3) minutes of their name being announced, that winner will be disqualified and another winner will be randomly selected.
 - In the event that a second name is drawn, that person will have two (2) minutes from the time their name is announced to approach the draw area and identify themselves to the Contest Sponsor in order to claim their prize. In the event that the second name drawn does not approach the draw area in the time allotted, that winner will be disqualified and another winner will be randomly selected.
 - Any further potential winners whose name is drawn will have one (1) minute to approach the draw area and identify themselves to the Contest Sponsor in order to claim their prize.
 - The initial selected customers will be disqualified and will have no recourse towards the Contest Sponsor.
 - At least two (2) registered gaming employees will be present at the Prize Draws at Baccarat Casino and Palace Casino.
 - Eligible entrants as defined above can win a maximum of one (1) of the prizes as outlined above, each week.
 - All entries will be counted and sorted by location after each draw.
 - A copy of the winning entry shall be marked "Winner" and attached to the completed Winner's Authorization Form along with any disqualified entries, marked "Disqualified".
 - Baccarat and Palace Casino's respective Surveillance Departments will videotape the draws when they are being conducted.
 - In order to be eligible to claim their prize, each Prize Winner must:
 - Produce valid identification and, if requested by the Contest Sponsor, proof of age and photo identification.
 - Produce a valid Player Rewards card whose number exactly matches the Player Rewards number on the Contest ballot.
 - Correctly answer (un-aided) a time-limited, mathematical, skill-testing question to be administered by the Contest Sponsor.
 - Complete a "Contest Authorization Release Form" including verification that they meet the requirements as an eligible entrant as outlined under the "Entrant Eligibility" section above.
 - If the above requirements are not met, the winner will be disqualified and another winner will be selected in their place.
 - By entering this Contest, participants consent to the Contest Sponsor publishing or announcing the winners' name and photograph, in future publicity, without permission or compensation.
 - Prizes must be accepted as described; substitutes by the Contest winner will not be allowed and the Prize may not be transferred to other persons without written consent of the Contest Sponsor.
 - Winners must accept prizes as awarded. No substitutions or transfer of the Prize will be allowed.

- The Contest Sponsor retains the right to replace the Prize with a different Prize of equal or greater value if the original prizing becomes unavailable for reasons beyond the Contest Sponsor's control.
- Entry ballots received by eligible entrants must be obtained by an entrant swiping their valid Player Rewards Card through the Player Rewards kiosk (a maximum of 1 ballot per person, per day), by an entrant turning in Slot Point Cards (a maximum of 3 ballots per person, per day) or by an entrant redeeming one hundred (100) Player Rewards Points at the Player Rewards kiosk (a maximum of 1 ballot per person, per day).
- In the event that the Player Rewards kiosk(s) are not operational due to technical difficulties or other reasons beyond the Contest Sponsor's control, the Contest Sponsor will provide patrons with paper ballots that can be used to enter instead, until such time as the Player Rewards kiosk(s) are operational again.
- Each entry ballot printed off the Player Rewards automatically contains: the date and time, the eligible entrant's Player Rewards Account Identification number, customer name and reference to where full terms and conditions can be found.
- Entries made with multiple addresses, under multiple identities, or through the use of any device or artifice to enter multiple times or entries that are in excess of the permitted number of entries during the Contest period are automatically void.
- All entry ballots earned by redeeming Slot Point Cards must bear the Gateway Casinos & Entertainment Inc. logo stamp to be considered a valid entry ballot for this contest.
- All Contest entries obtained through unauthorized sources or which are incomplete, illegible, mutilated, altered, reproduced, forged, irregular or fraudulent in any way or otherwise not in compliance with these Rules are automatically void.
- If a selected entrant is awarded the Prize due to a system error, malfunction or defect, the Prize will be returned to the Prize pool, to be re-awarded.

Conduct

- By participating in the Contest, each entrant agrees to be bound by the Contest Rules & Regulations, which will be posted and available at Guest Services located at both Baccarat Casino, Palace Casino and online at www.baccaratcasino.net and www.palacecasino.com
- Entrants further agree to be bound by the decisions of the Contest Sponsor, which shall be final and binding in all respects. The Contest Sponsor reserves the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules & Regulations; (b) tampering or attempting to tamper with the entry process or the operation of the Contest; (c) violating the terms of service, conditions of use and/or general rules or guidelines of Baccarat Casino and Palace Casino; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
- These Contest Rules & Regulations constitute the complete rules and regulations associated with this Contest.

Indemnification By Entrant

All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

Termination

Contest Sponsor reserves the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

Law

These are official Contest Rules. This Contest is subject to applicable federal, provincial and municipal laws and regulations. These Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Alberta including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
